Public Question Time

Several persons present expressed concern about a possible breach of planning at Kantara, Startley, i.e. change of use from private domestic to business use of the garage. Wiltshire Councillor Sturgis advised that any report to Development Management or himself would have to be backed up by a log evidencing vehicle movements, parts deliveries, working hours and dates otherwise the Council would be unable to take any action.

Some felt that the garage and store (19/06280/FUL) were disproportionately large for the property and too close to the boundary fence.

Wiltshire Councillor Report

Wiltshire Cllr Sturgis informed the meeting that the recent Public Health England report showed the county benefitted from higher life expectancy than the national average. The county had also received a top marks in its Ofsted report on Child Care Services. He further reported that householders who engaged unlicensed persons to take away scrap and refuse would be fined if fly-tipping occurred.

The permissive path across the Great Somerford showground to the weir has been closed due to poor behaviour by some individuals (litter, damage to fences etc.). Application for a permit to walk can be made by local residents to himself or Sid Jeavons.

- 19/04656/FUL 1 Manor Park Remove existing conifer hedge along West Street boundary and replace with 2m high wooden fence. Objection. Though the Parish Council will be pleased to see the Leylandii hedge that encroaches onto the pavement removed it objects to the 2m high vertical board fence as it is inappropriate and out of keeping along this prominent area of the village conservation area, and would suggest a lower fence with some planting of native hedging species in front to soften the fencing.
- 19/06280/FUL Kantara Proposed garage & store extension to the side of property. No objection.
- 19/06500/VAR Brook Farm variation of sundry conditions re 13/05915/VAR re implementation of planning permission 04/02024/OUT. Supported but concern was expressed that ongoing provision should be made for a turning facility for large vehicles such as refuse lorries in Frog Lane. Further issues raised concerned the unimaginative design of the housing units and worries whether the increased hard landscaping consequent upon development would exacerbate the surface flooding regularly experienced in Frog Lane.
