Minutes of the virtual meeting held Wednesday 1 July 2020 @ 7.30p.m. using Zoom Video Conferencing software

Public Question Time – The Chair welcomed those members of public present and gave them the opportunity to speak.

- A question was raised about when the **Play Area** would be opened and the Chair said this would be covered under item **20/07/2.2.**
- One person spoke in favour of naming the **new road** on the Broadfield Farm development after the Rev'd Stephen Demainbray, the Rector who created the Free Gardens in 1806 and was a significant person in the history of the village. This was covered under item **20/07/3.1.**
- One resident was concerned lest those who live in numbers 1 5 Broadfield Farm be forced to change their address if the new road were to start by the Old Mason's Arms. See item 20/07/3.1.

Reports from Unitary Cllr and Council Representatives - Wilts Cllr Sturgis Cllr Sturgis informed the meeting that

- Wiltshire Council was not on the verge of declaring a section 114 notice (being on the verge of bankruptcy) despite notices to that effect in the Press. He assured those present that the Council had £15m in reserves and was expecting Central Government Grant funding to compensate in part for the additional costs of dealing with the Covid 19 pandemic.
- **20/03/WCR West Street footpath.** Wilts ClIr Sturgis stated that the pipe, membrane and gravel which were at Brook Farm should have been installed by now had it not been for a lack of farm staff due to Covid 19; it would be done as soon as possible.
- Malmesbury Town Council and the ongoing validity of Neighbourhood Plans. He
 felt that local plans still carried considerable weight and pointed out that, despite
 Malmesbury Town Council's application to the Secretary of State regarding the
 planning permission for residential development on land not zoned for such in its
 Neighbourhood Plan, the Minister had not called it in and the planning permission
 remained in place.
- Risk of **local lockdown** being re-imposed in Wiltshire had been exaggerated by the media reporting a 300% increase in new cases. The actual increase was from 1 to 4 with 110.4 persons per 100,000 of population being infected. Wiltshire was one of the least impacted regions in the country.
- 20/07/1 **Apologies for Absence & Declarations of Interest –** None.
- 20/07/2 Minutes and Matters Arising
 - i The Minutes of the Parish Council both held on 3 June 2020 were approved and signed



by the Chair as a true record. Proposed: Cllr Blount; seconded Cllr Griffiths.

ii Action Register of Matters Arising

This was noted without detailed comment. Matters arising that were discussed were

- 20/04/4 & 20/06/6.3 Re-opening of the Winkins Lane Play Area. It was noted that Government Legislation now permitted outdoor play areas to re-open from 4 July provided the owners/managers had carried out a Covid 19 Risk Assessment and felt it was safe to do so. Members had been provided with extracts from the Government Guidance on "Working Safely during Covid 19" and "What you can do from 4 July". The "Covid 19 Guidance for managing playgrounds & outdoor gyms" had been circulated in full to all. Key remains social distancing, signage, maintaining hygiene (handwashing, sanitation of touch surfaces) and an inspection of equipment for safety before re-opening.

It was confirmed by Cllr Cole that all the major ROSPA recommendations from the September 2019 inspection had been actioned. Copies of these and the latest ROSPA report had been sent to all Councillors on 30 June.

Councillors recognised a strong desire from parents to allow their children to enjoy the facility. It was noted that the Play Area was, and would remain, unsupervised and the burden of maintaining safe practices whilst in use would have to remain with the parents and carers of those children using the facility. It would not be practical for the Parish Council to carry out a regular sanitisation programme or to monitor the behaviour of users. Parents should take reasonable precautions.

After discussion of these points it was **decided** to re-open on 4 July subject to

20/07/3 Housing Development – Broadfield Farm

i Backhouse Construction Ltd provided two suggestions for the name of the new street on the Broadfield Farm housing development, being Broadfield Close, Road or Lane or simply Broadfields and members of the public had suggested Ted's (or Edward's) View, Broadfield Close or Gardens, Demainbray Close or Gardens and Roady McRoad Face.



After discussion of the options and being mindful of Wiltshire Council's point that proliferation of similar names (such as Broadfield Close or similar coming off Broadfield Farm) causing problems with delivery drivers or delays for Emergency Services, the significance of the Rev'd Demainbray to the village and the concern about residents having to change their address it was **decided** to propose to Backhouse Construction the first choice name of Broadfield Farm starting at number 6 with Demainbray Close or Gardens as the second choice.

Proposed: Cllr Mansfield; seconded: Cllr Blount.

The Clerk would make Backhouse Construction Ltd aware of this proposal and, subject to their consent to the proposed name, was **authorised** to sign Form A on behalf of the Parish Council and send it to the developer (Backhouse Construction).

It was noted that Councillors were meeting Backhouse Construction on 2 July to discuss the pathway from the site to the Shop and, in their guise as Trustees of the Free Gardens, a possible footpath across the Free Gardens to the School.
