### 22/07/PQT **Public Questions**

A member of the public raised that a paragraph in article of June's Signpost regarding use of the Glebe field was inaccurately worded and could cause misunderstanding. Clarification was given that the Parish Council, in response to a public consultation in 2019 where 75 people participated and clearly wanted a space to kick a ball, had considered a section at the far end of the Glebe field as one of a number of options for that purpose. Members of the public present raised concerns about any plans that might take away the space for dog walking. The Parish Council will continue to consider options.

### 22/07/WCR Reports from Unitary Councillor and Council Representatives

Wiltshire Cllr Threlfall reported that there have been some waste collection issues due to staffing levels at Hills as well as a recent strike. After 2 days parishioners can log a collection issue via the Wiltshire APP.

Wiltshire is the second best county in terms of helping Ukrainian refugees, with 1454 people housed

Flooding and ditches clearance info has been sent from North Wilts There is currently a heritage watch for churches and listed buildings and police are encouraging people to be aware of potential threat to robbery of lead from roof tops. Cllr A Lennox wrote a letter regarding speed cameras (to the Police commissioner?) and police and the crime commissioner are conducting a survey. No questions raised

### i Monthly Finance Report

• The Finance report was **received.** The Parish Council **ratified & approved** transactions processed since the last meeting (£3377.81 payments, mostly due to the new speed sign, which is covered by CIL monies) as detailed in the appendix to the minutes, (approved as above). The bank balance stood at £93,528.19. CIL funding was discussed and explained as being eligible for capital purchases within the defined period, but not ongoing maintenance/operational costs.
