

Great Somerford (incorporating Startley) Parish Council

Meeting held in The Community Room on the 4th March 2026 at 7.30pm

Minutes

Present; Cllrs Griffiths (Chair), Todd, Gravell, Evans, Phillips, Harrison, Sturgis (Vice Chair) & Harper

Also present: Claire Mann (Locum Parish Clerk), Cllr E Threlfall (WC) and 1 member of the public

PQT Public Question Time (limited to 10 minutes)

The member of the public stated that the Gt Somerford Community Fund would like to tidy up the entrances to the Village with planting that would require minimum maintenance by volunteers, a proposal will be put to the Parish Council at the next meeting. It was suggested that the Village might wish to enter the Best Kept Village Competition.

WCR Reports from Wiltshire Councillor and any items for consideration from Local Groups.

Cllr Threlfall reported that WC had set its budget at the last Full Council meeting; a loss has been incurred from Central Government due to Labour incentives favouring northern counties. There is a 4.9% increase on Council Tax and U-turn decisions have been made by the new administration on the proposed closure of Household Recycling Centres and the defunding of the Link Scheme. Household recycling and refuse collections will be made three weekly rather than fortnightly and the introduction of soft plastic and food waste recycling will come in. Other concerns of note from Cllr Threlfall as follows;

- Increase in parking charging hours
- Parish Steward hours are to be cut/services to Parishes
- The Local Highways and Footpaths Improvement Group is being pressed to subsidise substantive bids over smaller applications for funding.
- The new administration plans to borrow £15m to fund highways and road maintenance.
- The Conservatives had proposed 'lane rental' when closing roads to help save £2m.
- The Wiltshire Local Plan is likely to be rejected by Planning Inspectors.

Cllr Threlfall has received assurances that the pot holes in West Street in the Parish will be patched, the request for a SID in Top Street has been put forward and the 'No HGVs' initiative in Winkins Lane is progressing.

Following discussion it was agreed that Cllr Sturgis will write to the portfolio holder for Highways to request that highway resurfacing is placed as higher priority than a 20mph speed limit in Malmesbury.

It was noted that Cllr Sturgis is continuing to establish land ownership and actions for Manor Park trees. The soakaway and drainage issues at Frog Lane has been completed and Cllr Evans will post on the Village Facebook requesting that vehicles do not park on pavements on the Dauntsey Road.

Other Items on the register would be covered later in the agenda.

CIL Projects

It was agreed that the eroded capping stone at the Church Wall would be replaced by Corinium Stone. It was noted that there is a leak in the Bus Shelter at Startley but that it is covered by warranty.

a) To receive update on the MUGA Feasibility Report

Cllr Phillips had circulated the report. It was noted that a licence is to be acquired and the Glebe Field is the preferred location. Actions to be taken are to communicate with the Free Gardens CIO, consultation with residents and to undertake a referendum for all residents. Further discussion on next steps will take place at the next Parish Council meeting.
